The public hearing to consider the adoption of the OBOA One, Two and Three Family Dwelling Code, 1999 Edition and all appendices was convened this 20<sup>th</sup> day of February 2001, in the Commissioners Meeting Room.

Larry Crisenbery opened the public hearing by reading aloud the resolution, which established the time and date of this public hearing.

Jerry Spurling, Chief Building Official, stated that the main difference between the version of the code, which is in place now, and the one proposed to be adopted is that smoke detectors are required in each bedroom instead of outside of each bedroom. He then stated that most of the builders have been anticipating the change and are already complying with the requirement.

Daniel Hendricks, Cincinnati Home Building Association, presented a letter endorsing the adoption of the new building code.

Upon further discussion, the public hearing was closed.					

Dana Storts, Solid Waste Management Director, was present for the monthly meeting of the Warren County Solid Waste Management District.
