2002 TRANSIT GRANT APPLICATION CAPITAL AND OPERATING

The publics hearing to consider the 2002 transit grant application was convened this 28th day of August 2001, in the Commissioners' Meeting Room.

Mr. Haddix, Grants Coordinator, explained the proposed grant application.

Commissioner Kilburn stated his desire to take care of the elderly services first and transportation to work as a second priority. He stated that, in his opinion, the need to accommodate people to a doctor's appointment, even if it is in the evening, should be first priority.

Commissioner South stated his agreement with Commissioner Kilburn but stated her opinion that the Board has a responsibility for job transportation as much as medical.

Herb Brown, concerned citizen, stated that he was charged \$640 to be transported from one hospital to another.

Upon further discussion, the public hearing was closed.
