DISCUSSIONS

On motion, upon unanimous call of the roll, executive session was entered into at 9:00 a.m. to discuss contract negotiations and personnel matters and exited at 11:10 a.m.

Ted Priest, Chief Zoning Official, was present for the site plan review of Brian Rausch in Washington Township.

Mr. Priest stated that the applicant desires to place an excavating company on the property that is zoned General Business "B-2". He then reviewed the comments from all departments and officials concerned and stated the recommendation to approve the site plan subject to three conditions.

Doug Jones, builder/developer for Mr. Rausch, stated the size of the building to be 124 square feet of office space with 100x48 as the main building.

Brian Rausch, 6230 Ludlum Road, stated that the only time the equipment will be at the location is when it is in need of repair and it will be stored in the building.

Upon further discussion, the Board resolved (resolution #01-1522) to approve the site plan review subject to three conditions.

PUBLIC HEARING ANNEXATION PETITION OF JOHN QUINN, AGENT TO ANNEX 17.047 ACRES TO THE VILLAGE OF SOUTH LEBANON

The public hearing to consider the annexation petition of John Quinn, agent to annex 17.047 acres to the Village of South Lebanon was convened this 18th day of September 2001, in the Commissioners' Meeting Room.

Mr. Quinn stated that all legal requirements have been met and the property owner wants to have sewer services for the lots and the church.

Russell Kilburn, Union Township Trustees, stated the trustees are in favor of the annexation petition.

Upon further discussion, the Board resolved (Resolution #01-1523) to approve the annexation petition.

Commissioner Kilburn entered the meeting at 1:35 p.m.

On motion, upon unanimous call of the roll, executive session was entered into at 1:45 p.m. to discuss personnel matters and exited at 2:30 p.m.

PUBLIC HEARING ANNEXATION PETITION OF J. WILLIAM DUNING, AGENT

TO ANNEX 251 102 ACRES TO THE VILLAGE OF MORROW

The public hearing to consider the annexation petition of J. William Duning was reconvened this 18th day of September 2001, in the Commissioners' Meeting Room.

Commissioner Kilburn opened the public hearing by reading aloud the resolution, which authorized the continuance of the public hearing and swearing those desiring to testify during the public hearing.

Paul Herdman, property owner within the annexation, spoke in favor of the annexation stating it is in the best interest of the Village and his property to annex. He stated his desire to more police protection.

Bob Brown, Mayor of Morrow, testified in favor of the annexation petition.

Fred LaFollette, Village Administrator and Fire Chief, presented testimony relative to the services available to the property and spoke in favor of the annexation.

Russell Kilburn, Village Police Chief, stated the police service available to the property and spoke in favor of the annexation petition.

Mr. Shrader, Attorney for Township Trustees, stated that the Trustees are opposed to the annexation petition. He stated that there are seven of eleven property owners who signed the petition according to the statement by agent and the Warren County Engineer's Office disagrees. He stated the concern that people are being included in the petition that do not want annexed. He then stated that the property is unreasonably large and presented evidence in opposition to the annexation.

Mark Florence, Attorney, stated that he was hired to do a title search on the property within the annexation petition. He then presented certified copies of deeds of all properties within the annexation.

Commissioner Kilburn questioned if the Board should direct the Agent to compose briefs relative to the position on the percentage of land ownership legality in the statement by agent presented to the Board.

Mr. Duning stated he would submit proof of authority of signature rather than a brief.

Ron Gilbert, property owner within the annexation, stated he does not desire his property to be annexed.

Donnie Williams, Township Trustee, stated that the annexation is not in the best interest of Salem Township.

Paul Wolf, Township Trustee, stated his opposition to the annexation.

Lynn Whitacre, Zoning Inspector for the Township, stated that he has never been approached relative to rezoning for any property within the petition for annexation.

Richard Dare, Township Trustee, stated that all the services to the property are already in place and stated his opposition to the annexation petition.

Jillora Summers, property owner within the annexation, clarified the chain of title relative to the property owned by herself and family members.

The Board requested the agent to consider deleting the property owners within the petition who do not want annexed wherever possible. Mr. Herdman also requested the same

Mr. Shrader presented closing arguments in opposition to the annexation petition.

The Board stated a deadline of October 4, 2001, for submitting proof of ownership.

Upon further discussion, the Board continued the public hearing to October 23, 2001, at 11:00 a.m.

Upon motion the meeting was adjourned.
