## REZONING APPLICATION OF CHARLES EVANS TO REZONE 0.386 ACRES IN UNION TOWNSHIP FROM GENERAL BUSINESS "B-2" TO ONE AND TWO FAMILY RESIDENCE "R-2"

The public hearing to consider the rezoning application of Charles Evans to rezone 0.386 acres in Union Township from General Business "B-2" to One and Two Family Residence "R-2" was convened this 30<sup>th</sup> day of October 2001, in the Commissioners Meeting Room.

Mr. Evans stated it is necessary to rezone his property as he had constructed a shed on his property and, in order to comply with the building permit, must rezone.

The Board discussed the reason for the rezoning application and Commissioner Kilburn stated his desire to refund Mr. Evan's application fee.
