Mr. Tunison stated that changes in the Ohio Revised Code through HB 549 allow the creation of stormwater districts, similar to the water and sewer districts are created, which allows the County to correct stormwater problems through assessments.
He stated the need to do a general plan of service and his desire to begin the procedure for acquiring an engineering firm to begin the process of creating a general stormwater plan.
