Mr. Spurling stated spoke in opposition of the Village of South Lebanon providing their own inspections services.

Jim Smith, Mayor of South Lebanon, and John LouAllen, Village Administrator, stated their desire to begin providing their own building inspections and requested the Board to waive the sixty day notice requirement in the agreement and terminate the contract.

Upon further discussion, the Board resolved (Resolution #01-2223) to waive the sixty-day termination clause and terminate the contract with the Village of South Lebanon for inspection services.

Richard Renneker, Sanitary Engineer, was present along with representative from the City of Springboro to discuss the purchase of a Warren County waterline by the City of Springboro.
