On motion, upon unanimous call of the roll, the Board entered into executive session at 4:45 p.m. to discuss contract negotiations and exited at 5:45 p.m.

PUBLIC HEARING

REZONING APPLICATION OF MICHAEL AND CINDI ASH (CASE #01-12) TO REZONE 1.087 ACRES IN WASHINGTON TOWNSHIP FROM GENERAL BUSINESS "B-2" TO ONE AND TWO FAMILY RESIDENCE "R-2".

The public hearing to consider the rezoning application of Michael and Cindi Ash (Case #01-12) to rezone 1.087 acres in Washington Township from General Business "B-2" to One and Two Family Residence "R-2" was reconvened this 17th day of January 2002, in the Commissioners' Meeting Room.

Mr. Ash, property owner, stated his desire to construct a two family on the property. He stated his desire to live in half and rent the other half as income after retirement. He also stated his desire to construct a garage on the property.

Robert Craig, Regional Planning Commission (RPC), review the area and surrounding zoning and stated the RPC Executive Committee's recommendation to modify the application to approve a Rural Residence "R-1".

Ted Priest, Chief Zoning Official, stated that the Zoning Department received notification that the Washington Township Trustees do not recommend approval. He then reviewed the events of the Rural Zoning Commission meeting and stated their approval of the rezoning application.

Commissioner Kilburn stated his concern relative to spot zoning and stated he does not want to send a message to other residents in Warren County that it is okay to change from single family to multi-family when there is not any surrounding multi-family.

Mr. Ash stated that if the Board does not allow him to construct a duplex on the property then he would have to pursue other business relative options as the property is currently zoned General Business "B-2".

Commissioner Kilburn stated his approval of a waiver of the application fee if Mr. Ash would desire to apply for a zoning variance to allow construction of a garage on the property but not his support to the zoning to multi-family.

Upon further discussion, the Board resolved (Resolution #02-91) to continue the public hearing to January 24, 2002, at 5:30 p.m.

The Union Township Trustees were present along with the County Engineer and several residents from the Shawhan Road, Dry Run Road, and Snook Road area to discuss their desire to limit the gross vehicle weight for times during moisture and thaw (freeze-thaw).

Commissioner Kilburn questioned if there are legal requirements that must be complied with prior to any legislation being enacted.

Neil Tunison, County Engineer, stated that there are no legal requirements under the "freeze/thaw" section of the law they are requesting the Board to take action on. He stated that, if enacted, it would place restrictions for a certain length of time which would restrict load limits.

Tammy Luzinger, Snook Road resident, stated her desire to eliminate the truck traffic on her road.

Fred Oeder and Tim Browning, Oeder & Sons Gravel, stated that the ban of truck traffic in South Lebanon necessitates the truck traffic in the area.

Joe Johnson, Steve Jones, Paula Lucas, Ethel Ledford, and Ross Ertel all spoke in favor of reducing the speed limit and load limit for the area.

Jamie Bailey, Shawhan Road resident, questioned how the farmers would get their grain out if they cannot haul on the roadways.

Upon further discussion, the Board continued the discussion to January 24, 2002, at 6:00 p.m.
