PUBLIC HEARING

REZONING APPLICATION OF MICHAEL AND CYNDI ASH TO REZONE 1.807 ACRES IN WASHINGTON TOWNSHIP FROM GENERAL BUSINESS "B-2" TO ONE AND TWO FAMILY RESIDENCE ZONE "R-2"

The public hearing to consider the rezoning application of Michael and Cyndi Ash to rezone 1.807 acres in Washington Township from General Business "B-2" to One and Two Family Residence Zone "R-2" was reconvened this 24th day of January 2002, in the Commissioners' Meeting Room.

Commissioner Kilburn stated the event of the January 17, 2002, public hearing and explained that Mr. Crisenbery has reviewed the testimony given at that meeting.

Denver Williams, Washington Township Trustee, stated their concern with the septic capacity and the electrical problems. He then stated his opinion that this property should remain zoned General Business "B-2."

Upon further discussion, the Board resolved (Resolution #02-149) to deny the rezoning application.

The Union Township Trustees were present along with Neil Tunison, County Engineer and several residence from the Dry Run Road, Snook Road and Shawhan Road areas to discuss the truck traffic from Oeder and Sons Sand and Gravel.

The Board stated their concern relative to the legal aspects of enacting the proposed legislation and stated their desire to consult with the County Prosecutor.

Upon further discussion, the Board continued the discussion to February 7, 2002, at 6:00 p.m.
