## PUBLIC HEARING CONTINUATION OF THE ANNEXATION OF 266.7206 ACRES TO THE VILLAGE OF SOUTH LEBANON, PAUL BAKER, AGENT

The public hearing to consider the annexation petition of Paul Baker, Agent to annexation 266.7206 acres to the Village of South Lebanon was reconvened this 21<sup>st</sup> day of March 2002, in the Commissioners' Meeting Room.

Catherine Cunningham, attorney for agent, presented an amendment to delete territory from the original petition. She then presented affidavits in support of annexation from all property owners, which remain in the amended petition.

William Ritchey, attorney for Hamilton Township, stated his desire to ensure that the road right of way in not included in the amended petition.

Commissioner Kilburn requested the Township Trustees and Village of South Lebanon to "sign off" on the actual amended map and legal description prior to the final approval of the Board. Upon approval by other the Township and Village, the Clerk of Commissioners will present an order for annexation to the Board for approval.

Mr. Ritchey withdrew his objection to the annexation and his concurrence to the annexation of the property stated in the amended petition.

C. Francis Barrett, attorney representing the Tournament Players Club, stated his client's objection to their property being included in the annexation petition and his pleasure with the property being deleted from the amended petition. He then presented video testimony from Arnold Palmer in opposition to the annexation.

The Board thanked the Village and the Township for the cooperation between the two entities in reaching a settlement relative to the annexation petition.

Upon further discussion, the Board resolved (Resolution #02-495) approved the amended petition to annex approximately forty acres to the Village of South Lebanon subject to an accurate map and legal description and approval of said map by the Village of South Lebanon and Hamilton Township.

## PUBLIC HEARING ANNEXATION PETITION OF STEVEN WALLACE, AGENT TO ANNEX 16.842 ACRES TO THE VILLAGE OF SOUTH LEBANON

The public hearing to consider the annexation petition of Steven Wallace, agent to annex 16.842 acres to the Village of South Lebanon was reconvened this 21<sup>st</sup> day of March 2002, in the Commissioners' Meeting Room.

William Kaufman, attorney for agent, stated that all property owners desire to be annexed. He then presented affidavits from all property owners within the annexation petition, the agent and copies of all deeds of property within the petition and stated that all legal requirements have been met relative to the annexation.

John Quinn, attorney for the Village of South Lebanon, clarified that all road right of way in included in the petition for annexation.

William Ritchey, attorney for Hamilton Township, stated he will offer no evidence in opposition to the annexation petition.

O.T. Bishop, Hamilton Township Trustee, stated his desire for the Village to be aware of a water retention/drainage problem in the area being annexed.

Upon further discussion, the Board resolved (Resolution #02-496) to approve the annexation petition.

On motion, upon unanimous call of the roll, executive session was entered into at 4:37 p.m. to discuss personnel matters and exited at 5:10 p.m.
