## DISCUSSIONS

William Schroeder, Warren County Park Board, was present to give an update on the status of the various Issue 2 Grant applications.

The Board discussed the Integrating Committee's desire to have entities "scale down" the grant applications where possible to enable all projects to be funded.

Mr. Schroeder requested the Board to approve an amendment to the Caesar Creek grant application to delete the construction aspect from the project and only request the funds to appropriate the property.

Upon further discussion, the Board agreed to his request.

Larry Stone, Turtlecreek Township resident and representative of Cornerstone Consulting, stated his desire to pursue the concept and construct of a community arts pavilion in Warren County.

Lance Francis, Techtonic Engineering, a national engineering firm, was present to introduce their firm to the Board of Commissioners.

Neil Tunison, County Engineer, was present along with David Query, Kings School Superintendent, to discuss road improvements suggested by a Deerfield Township resident, Rhonda Michael, relative to safety concerns in front of Kings High School and Junior High School.

Mr. Tunison stated his desire to cooperate with the school and Mrs. Michael and stated he will work on improvements for a desired completion date of mid-fall.
