## **PUBLIC HEARING**

## ALTERATIONS TO THE ROAD RIGHT-OF-WAY FOR PORTIONS OF MORROW COZADDALE ROAD

The public hearing to consider alterations to the road right-of-way for portions of Morrow Cozaddale Road in Hamilton Township was convened this 23<sup>rd</sup> day of July 2002, in the Commissioners' Meeting Room.

Bruce McGary, Assistant Prosecutor, reviewed the previous events of the public meeting with Western Water. He then stated that the hearing has been properly advertised, proper notice has been given to the adjacent property owners and the report and plat from the County Engineer has been received.

Mr. Kilburn stated that the redesigning of the road right-of-way to 17 ½ feet for the Whitt, Gilcher, and Weber properties is what is being considered.

The Board stated their desire to alter the road right-of-way.

Upon further discussion, the Board resolved (Resolution #02-1126) to approve the alteration of the road right-of-way for Morrow Cozaddale Road in Hamilton Township.

Tim Oliver, Tom Ariss and John Lazares were present for a work session relative to the use of drug forfeiture money for the payment of drug testing school students participating in extra-curricular activities as allowed by the recent Supreme Court decision.

Upon discussion, the Board determined that Commissioner Kilburn will meet with Mr. Lazares and the Warren County School Superintendents at the September 13, 2002, meeting to discuss the proposal.

Neil Tunison, County Engineer, was present for a work session with Adam Reckman, Jackson-Runyan Road in Harlan Township, to discuss the proposed road improvement project, which will encompass a portion of their property.

Mr. Tunison stated that the Harlan Township Trustees are in favor of the project as the intersection proposing to be improved is very dangerous and in need of improvements.

Adam Reckman, 9440 Jackson-Runyan Road, stated that if the grassy area were manicured, the road improvements would not be necessary. He stated his opinion that the site distance would be greatly improved if the weeds and trees were removed from the road right-of-way.

Mr. Tunison informed the Board that in order to proceed with the project, the County will need 1/10 of an acre from Mr. Reckman.

Webb Logan, Harlan Township Trustee, stated that this intersection is one of the worst intersections in the Township and the Board needs to proceed with the project to improve the safety of the intersection.

Upon further discussion, the Board stated their desire to view the proposed project and proceed with the improvements.

Abbott Thayer, Peck, Shaffer & Williams, was present to explain the bond refinancing resolution which were necessary in order to allow a cost savings to the County of \$375,000.00.

Richard Renneker, Sanitary Engineer, was present along with Bruce McGary, Assistant Prosecutor, were present for a work session to discuss water and sanitary sewer service to property on Columbia Road in Deerfield Township.

Mr. Renneker explained that water and sanitary sewer services should be provided by Warren County. However, the City of Mason will not issue a building permit unless the water service is received from the City of Mason.

Mr. Renneker explained that the developer has already paid a water assessment to Warren County for the line and he should not have to pay twice to receive water.

Upon further discussion, it was determined that Mr. Renneker and Mr. Kilburn would meet with the Mayor of Mason.

Ted Priest, Chief Zoning Official, was present for the site plan review application of Rick Barklow in Union Township.

Mr. Priest stated that the embroidery business desires to move three houses down the street and then presented his recommendation to approve the site plan review application.
