Isabell Davis, Simpson Creek Farms resident, was present with problems and concerns relative to the conditional use permit for Cincinnati Hills Christian Academy in Deerfield Township.

Mrs. Davis stated that Deerfield Township has approved a 600-person soccer stadium with 334 parking spaces and no buffer to the adjacent residential subdivision. She then stated that the Township Zoning Appeals Board has denied the residents their due process in the procedure.
