Jim Crane, Wayne Township resident and former Township Trustee, was present and read a letter in opposition to video lottery terminals being proposed at racetracks within the State of Ohio.

Richard Palow, attorney from John Henry Homes, was present along with their geotechnical engineer, and also a representative from their concrete company to discuss the construction of a foundation along with pier walls in Hamilton Township without a building permit.

John Henry Homes was present to appeal a building department decision to deny their inspection.

Upon further discussion, the Board determined to take the information under advisement for a decision at a later date.

Richard Renneker, Sanitary Engineer, was present along with Bruce McGary and the Hamilton Township Trustees to discuss the need for one additional easement relative to the Sonny Lane Sewer Project.

The Trustees informed the Board that Marie Powell, the property owner, desires to have drainage concerns completed to the rear of her house prior to signing any sewer easements.

Upon discussion, the Board stated the desire to try one additional time for easements and begin court proceedings if the problem is not settled.

Commissioner Kilburn exited the meeting at 6:55 p.m.
