PUBLIC HEARING #2

PROPOSED INCREASE IN THE REAL PROPERTY TRANSFER TAX

The second public hearing to consider the increase in the real property transfer fax was convened this 18th day of February 2003, in the Commissioners' Meeting Room.

Dan Hendricks, Cincinnati Homebuilders Association, urged the Board to postpone the decision until they have had time to review all taxes.

Gene Snavely, Cincinnati Board of Realtors, presented a list of ten reasons to not approve an increase in the transfer tax.

Steve Feldman, Fisher Homes, stated that Ohio residents are already overtaxed and that Warren County has great economic growth and should not increase the transfer tax.

Robert Glover, Developer and Brad Knapp, Realtor, all spoke in opposition to an increase.

Sandy Blair, Realtor, presented a petition in opposition to the increase.

Bill Stallman, Turtlecreek Township resident and property owner, spoke in opposition to the increase.

John McMinn, President of the Area Progress Council, stated that the APC is not for or against the increase but rather has taken the position of an interested party.

Upon further discussion, the Board closed the public hearing and determined to render a decision on April 17, 2003, at 5:30 p.m.

The Board conducted a work session with most of the Warren County social service agencies to help the Board understand the social programs within the County and determine if any duplicative services are taking place.

Upon discussion, the Board directed each department to complete and forward a copy of their 2002 annual report as well as a "comprehensive" report for combined services for a work session to take place May 1, 2003, at 2:00 p.m.

Upon motion the meeting was adjourned.
