DISCUSSIONS

ANNEXATION PETITION OF ROGER ECKERT, AGENT TO ANNEX 140.925 ACRES TO THE CITY OF MONROE

The public meeting to consider the annexation petition of Roger Eckert, Agent to annex 140.925 acres to the City of Monroe was reconvened this 8th day of May 2003, in the Commissioners' Meeting Room.

Neil Tunison, County Engineer, stated that, upon review of the public records, none of the right of way of Union Road is included in the property owned by Mr. Berns. He also stated that a portion of the right of way of I-75 has been determined to be owned by Oberer Development, not the State of Ohio or Mr. Berns.

Jay Stewart, City of Monroe, stated their desire to delete all the right of way not included on Mr. Berns deed for a remaining acreage of 135.068. He stated that Union Road would remain in the Township and under the control of the County Engineer. He then presented proposed road maintenance agreements for the portion of the roadways proposed to be annexed into Monroe.

Roger Eckert, Agent for Petitioner, presented an amended map and legal description to annex 135.068 acres to the City of Monroe.

Dan Jones, Turtlecreek Township Trustee, stated the Township does not object to this single owner annexation.

Commissioner Crisenbery stated the need for the Tax Map Department to review the revised map and legal description for accuracy.

There was discussion with Bruce McGary, Assistant Prosecutor, relative to a small triangular island being created if this annexation is approved.

Jonathan Sams, Attorney for Mr. and Mrs. Sams, adjacent property owners, stated his withdrawal of objection to the annexation due to the Sams' property being deleted from the map.
