Neil Tunison, County Engineer, was present to discuss the need to order the utility companies to relocate utilities out of the road right-of-way in order to proceed with the Socialville-Foster/Snider Road intersection improvements.

Mr. Tunison presented a draft resolution ordering the utilities to be relocated and also discussed the need to utilize a portion of the \$6 million that the Board earmarked to dangerous intersection towards the improvements.
