## DISCUSSIONS

Dave Gartin, Hamilton Township property owner, was present to request the Board to lobby the Ohio Environmental Protection Agency to allow the DuPont Company to clean up their property adjacent to the Kings Mills Technical Center (Old Peter's Cartridge) under the Ohio Voluntary Action Program rather than the Federal "Superfund" program.

The Board informed Mr. Gartin that their choice for clean up would be whichever method was most stringent due to the Warren County Wellfield being adjacent to the property.

Upon discussion, the Board directed Richard Renneker, Sanitary Engineer, to draft a letter to the Ohio EPA to consider the most stringent clean up for the property for the protection of the area water supply.

On motion, upon unanimous call of the roll, the Board entered into executive session pursuant to Ohio Revised Code Section 121.22 (G) (1) Personnel matters and 5:43 p.m. and exited at 6:15 p.m.
