Mike Middendorf, developer of Hunter's Green, Section 4, was present for a work session along with Doug Beaudoin, property owners within Greenfield Subdivision (adjacent subdivision), the County Engineer and Joe Farruggia, developer of the adjacent subdivision, to discuss drainage issues within the two subdivision.

Richard Paylow, Attorney for Mike Middendorf, stated that his client is willing to cut a drainage way on his property to allow Mr. Beaudoin positive drainage from his property to the lake within Mr. Middendorf's property.

The Board discussed the permanent record of this agreement to ensure future maintenance of the drainage way.

Upon further discussion, the Board resolved (Resolution #03-1311) to rescind Resolution #03-1248 which restricted building permits from being obtained and inspections from being performed in Hunter's Greens, Section 4 subdivision in Deerfield Township.
