## **DISCUSSIONS**

Larry Long and Cheryl Subler, County Commissioners' Association of Ohio, were present along with Dana Walsh, Secretary of State Ken Blackwell's Office, for a work session to discuss the Help America Vote Act (HAVA).

Larry Long explained that under Federal law, there is no requirement to eliminate the punch card system. He stated that the requirement is to allow a "second chance" vote.

Dana Walsh stated that the Federal government has allocated \$155 million over three years. He stated that \$32 million has been appropriated by Congress to date. He then stated that the State of Ohio has appropriated the 5% required match in the Capital Budget Bill.

There was discussion relative to the cost of replacement and maintenance for the new voting system.

The Board stated their desire for Secretary Blackwell to apply for the waiver to allow other states to be the examples of the best system to purchase. The Board also stated their lack of desire to replace a system that works.

There was discussion relative to the deadline of January 1, 2006, for the requirement to be fulfilled in the Federal legislation, which requires unassisted voting for the disabled.

Upon further discussion, the Board stated, once again, their desire to apply for a waiver to delay the purchase of the new equipment.

Upon motion the meeting was adjourned.
