## DISCUSSIONS

Barry Sullivan, Zoning Department, was present for the site plan review application of the Warren County Park Board for a new park to be developed in Franklin Township.

William Schroeder, Park Commissioner, gave an overview on the history of the purchase of the properties along with the Three Rivers Park Board. He explained that the proposed park would contain approximately 500 acres and consist of two soccer fields, two baseball fields as well as a nature preserve.

Scott Pence, adjacent property owner, questioned if the Middletown Hydraulic Dam is included in the site.

Mr. Schroeder stated that it was not as we did not acquire ownership of that property.

There was much discussion relative to concerns with erosion on the property as well as problems with all terrain vehicles trespassing in the area.

Gloria Bohannon, area resident, questioned how many people are proposed to utilize the park. She stated concern with traffic and safety.

Mr. Sullivan reviewed the comments from other agencies and departments concerned and read aloud a letter from Richard Renneker, Sanitary Engineer, stating various restrictions he would like placed on the property to preserve the aquifer. He also stated suggestions from the Regional Planning Commission including reversing the direction of the ball fields.

Raymond Lee, adjacent property owner, questioned what type of fence will be erected along the perimeter of the property.

Mr. Schroeder stated that whatever fence was specified in the purchase agreement would be erected.

Mr. Pence questioned who would be responsible for scheduling the use of the ball fields.

Mr. Schroeder stated that in most cases, a community athletic association would be formed and have the responsibility of scheduling.

Bill Thacker, area property owner, stated he would like to see an ATV park in the future.

The Board stated that there is too much liability in those type of parks.
