Karen Garrett, Economic Development Director, was present to explain the cancellation of the enterprise zone abatement agreement for Spotlight Solutions, Inc.

Mrs. Garrett stated that the company has been sold and they do not desire to continue the abatement.

Upon further discussion, the Board resolved (Resolution #04-393) to cancel the enterprise zone abatement agreement between Warren County and Spotlight Solutions, Inc.

Neil Tunison, County Engineer, was present for a work session to discuss the need to transfer property owned by Warren County to the State of Ohio.

Mr. Tunison stated that Warren County bought a house at Sheriff's Sale with the intention of dedicating the needed right of way to the State of Ohio as our local contribution to the road project. He then stated that it would cost the County more money to survey the property than to just deed the entire parcel to the State.

Upon further discussion, the Board resolved (Resolution #04-394) to deed a parcel of land in Ridgeville (Clearcreek Township) to the State of Ohio.

Mr. and Mrs. Booker, State Route 122 in Franklin Township, were present to discuss the complaint relative to spending \$3,150.00 to connect to the Hunter Sanitary Sewer.

Mr. Booker stated that because of the location of the lateral, he spent \$1950.00 more than any other property owner within the project.

Upon further discussion, the Board agreed to reimburse one half of the overage (\$975) to Mr. and Mrs. Booker.
