Jake Jones, Director, Warren County Building Services, will review bids for a recommendation at a later date.

Beth Lowman, Franklin Township resident, was present requesting the Board to waive the partial tap-in fee for the property she is purchasing through a foreclosure from the bank located at 3140 Lynn Drive in Franklin Township.

Mrs. Lowman stated that she currently lives within the Hunter Sanitary Sewer District and her property is already connected to the sanitary sewer. She then stated that she is buying this property "as is" and it is currently not connected to the sanitary sewer. She then stated that until she has ownership and possession of the property, she is not permitted to make any improvements.

Upon discussion, the Board resolved (Resolution #04-459) to waive a partial tap-in fee in the amount of \$1900 for the property located at 3140 Lynn Drive in Franklin Township for Mr. and Mrs. Lowman subject to the closing and receiving of the deed on or before September 1, 2004.

Sheriff Ariss and Gary Browning, Data Processing Director, were present for a work session to request funding for the purchase of replacement computer equipment currently located within the Sheriff's Office.

Sheriff Ariss stated that the existing computer services and located in an area within his office which has no air conditioning and they need to be relocated to the Administration Building

within the Data Processing Department and also need to be replaced. He stated that the current servers are six or seven years old and continually cause problems within the operations.

It was determined that the cost to purchase and relocate the equipment will be approximately \$20,000 and upon further discussion, the Board agreed to the additional allocation of funds.

Commissioner Kilburn requested Bob Craig, Executive Director of the Regional Planning Commission, to attend the meeting to discuss the proposed new subdivisions in Turtlecreek Township.

Commissioner Kilburn stated his concern relative to the proposed 960+ new homes being proposed within the Lebanon School District stating concerns of overcrowding of the schools, traffic and many other problems associated with rapid growth.

Upon discussion, the Board stated their desire to investigation a moratorium on new building permits as a way to slow down growth in order for infrastructure to keep up with growth.

Mr. Craig stated he would investigate this issue with the Prosecutor's Office and report back at a later date.

Upon motion the meeting was adjourned.
