The Board convened their meeting into the Administration Parking lot to view communication vehicles with the Emergency Services Director.

Representatives from the Village of South Lebanon were present along with their legal counsel, Jay Revelson, Warren County Chief Deputy Prosecutor, Bruce McGary, and Richard Renneker, Sanitary Engineer, to discuss an agreement which would allow South Lebanon to purchase Warren County Sanitary Sewer capacity within the Lebanon Wastewater Treatment Plant.

There was discussion relative to the sewering of Highland Park Subdivision in Union Township.

Mayor Smith stated their concern for the Village constructing sewers for this area without annexation.

Upon discussion, the Board and the Village of South Lebanon agreed to Warren County reserving 50,000 gallons of capacity for the Highland Park Subdivision and transferring 250,000 gallons of capacity to the Village. There was also agreement that Warren County would pay 1/6 of the outstanding bill to the City of Lebanon and South Lebanon would pay 5/6 of the outstanding bill.

Upon discussion, the Board continued the discussion to September 16, 2004, at 5:05 p.m. in order to finalize a written agreement relative to this discussion.
