Mr. Elliott explained that the Board that if Mr. Estes completes this training, it should enable them to get by with not hiring three or four new employees for 2005.

Upon discussion, the Board approved for Mr. Estes along with Paul Bernard to attend the training session.

The Board met this 28th day of September for a work session with representatives from the Warren County Board of Mental Retardation and Developmental Disabilities Agency for an update of proposed renovations to the old Urbancrest building on Drake Road in Turtlecreek Township.

Pete Mason, Facilities Director for MR/DD, stated that the MR/DD Board desires to downsize the Urbancrest project, now known as the Warren C. Young Center. He stated that the new concept for the building is to house 85 staff members and 65 participants. He stated they have redesigned the building for hold three rehabilitation units within the existing sanctuary. He then reviewed the three most expensive items for the renovation will be as follows:

- Computer Technology
- Electric
- Sprinkler system

He then stated the bottom line estimate is not known at this time. However, the MR/DD Board has stated their ultimate goal is to complete the renovations for under \$1 million.

Gary Browning, Data Processing Director, was present along with County Auditor Nick Nelson to explain the request for Aaron Crane and Ben Cliff, Data Processing employees, to attend two years of classes at the New Horizons Learning center in order to stay current with new technologies relative to network support.

Mr. Browning stated that both employees have signed the required agreements that stated if they leave employment with a certain number of years, a reimbursement or partial reimbursement will be required.

Upon discussion, the Board approved the necessary paperwork.
