## DISCUSSIONS

Barry Sullivan, Zoning Department, was present for the continuation of the site plan review application of I-71 Self Storage in Washington Township.

Mr. South stated the reason for the continuation was for representatives from the University of Cincinnati, adjacent property owners, and the property owner to discuss the proposal.

Daniel Luther, representative from the University of Cincinnati, stated they have reviewed the project with the property owner and have no objections or concerns with the proposed construction.

Mr. Sullivan stated his recommendation to approve the site plan review application.

Neil Tunison, County Engineer, was present to discuss the Ohio Department of Transportation project at State Route 48 and Lower Springboro Road in Clearcreek Township.

Mr. Tunison stated that Warren County participated in this project by preparing plans, acquiring right of way and demolishing the grocery store within the road right of way. He then stated that it was necessary to increase the scope of the project to align the intersection. He presented final legislation from the State of Ohio for adoption by the Board.

Upon further discussion, the Board resolved (Resolution #04-1539) to adopt final legislation relative to State Route 48 and Lower Springboro Road.

Dr. Colon, Hamilton Township resident, presented a letter to the Board to officially request the reduction of the Sanitary Sewer Improvement Area in Hamilton Township to be the area equal to the Urban Service Area as designated by the Hamilton Township Trustees in the Hamilton Township Land Use Plan.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:50 a.m. to discuss personnel matters with the Human Resources Director and the Sanitary Engineer pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 11:30 a.m.
