DISCUSSIONS		

On motion, Upon call of the roll, executive session was entered into at 9:50 a.m. to discuss personnel matters pursuant to Ohio Revised Code Section 121.22(G)(1) and exited at 11:15 a.m.

Bill Shearer, Foster Maineville Road Resident, was present to speak of behalf of Lori Peters, Melrose Subdivision in Hamilton Township relative to various concerns.

Mr. Shearer, spokesperson on behalf of the residents within Melrose Subdivision and Liberty Springs Subdivision in Hamilton Township and the Village of Maineville stated the following concerns relative to drainage and other matters:

- Storm water surface grading has not been completed correctly
- Sump pump drains incorrectly installed
- Cannot find property line survey stakes
- Retention ponds not functioning property

There was discussion relative to the improvements completed after receiving complaints by Lucke Homes within portions of Melrose Subdivision. It was stated that there is additional grading they have committed to complete once the weather permits.

There was then discussion relative to improvement needed in Liberty Springs which has not been completed by the developer or by Beezer Homes (formerly Crossman Homes).

The homeowners' requested the Board to not release any bonding within Liberty Springs prior to consulting with representatives of the property owners.

The Board stated they would not approve any bond releases.
