DISCUSSIONS

John Kilburn, Washington Township resident, was present to discuss concerns with the Health Department relative to an apartment he formally resided within the City of Springboro.

Mr. Kilburn stated he lived in an apartment complex owned by K & E Property Management, Harry and Cathy Smith, managers, with his wife and small child. He stated the various health problems his family faced while living in the apartment and, upon inspection from an environmental engineer company, determined the apartment was infested with "black mold" and was directed to immediately vacate the premises.

He stated concerns with the Health Department's inability to remedy the situation.

Dan Collins, Board of Health, stated there is no standards or regulations on mold and therefore, there is no way to enforce any violations.

Upon further discussion, the Board stated they would request the establishment of standards and regulations on mold from the State Legislatures.

Bob Paola and Rick Weledge, Mason Youth Organizations and Mason Knothole Associations representatives, were present to state their concerns relative to the City of Mason's adoption of an ordinance, which would prevent Deerfield Township children from participating in teams who play on ball fields within the City of Mason.

Mr. Weledge stated the action is a result of a shortage of fields within the City. He stated that the City of Mason has thirteen fields and the Mason schools provide three fields.

There was discussion relative to Deerfield Township's commitment to construct additional fields with the assistance of the County Engineer, with the anticipation of being completed prior to the Spring 2005 season.

Upon further discussion, the Board signed a letter to the City of Mason urging them to reconsider their action and allow the children from Deerfield Township to continue to participate of teams within the City of Mason.
