DISCUSSIONS	

Elected Officials from the Warren County Common Pleas Court Building were present to discuss overcrowding within the Common Pleas Court.

Judge Flannery stated that the Common Pleas Court is in need of additional office space. He stated that Clermont County has just added an additional Judge and he anticipated Warren County to need an additional Judge within the next four years. He requested the Board to consider the process to consider an addition/renovation to the existing facility.

Rachel Hutzel, Prosecutor, stated that if the existing growth rate continues, her office would have a 20% increase in felony indictments for 2005. She stated that her current operation is separated into three different places within the building, due to the lack of space within her office area.

Mitch Bonhom, Child Support Executive Director, stated that the Child Support Enforcement Agency has seen a 35% increase in caseload within the last six years.

The Board discussed the need for long term planning and the need for an architect to complete a space study.
