DISCUSSIONS

Neil Tunison, County Engineer, was present to explain and discuss a contract between the Board and Edwards and Kelcey for a traffic impact study relative to the Greentree Road area.

Mr. Tunison stated that the proposal was for the entire area, not just one development on Greentree Rd.

Commissioner South questioned if an assessment/repayment based on a trip count or an equivalent residential unit (ERU) from each development could be utilized to recoup the engineering and construction of the necessary improvements.

Commissioner Young questioned why we are requesting a study and not going ahead and designing the improvements.

Mr. Tunison stated that more information is needed in order for the public to "buy into" the proposal.

There was discussion relative to establishing a transportation improvement district or an assessment district to finance the necessary improvements.

Upon discussion, the Board returned the proposed agreement and purchase order to Mr. Tunison and he stated he would get together with the County Administrator and the engineering firm to draft a contract and legislation that will accomplish the desired goals.
