DISCUSSIONS

Dave Gully, County Administrator, discussed the need to "overhaul" the Warren County Rural Zoning Code.

Mr. Gully explained the process and procedure he desires which includes a three-step procedure as follows:

- 1. Make immediately needed changes and include local officials and key stake holders in order to allow local input on things such as Agricultural Zone, Cluster Housing, and lot sizes which do not take into consideration whether the property is sewered or unsewered.
- 2. Hire a consult to totally "overhaul" the entire code, which includes public comment.
- 3. Revise the existing zoning map to conform to the newly adopted zoning code.

There was discussion relative to the process and timing of these things as well as discussion on the proposed cost of said process.

Upon discussion, the Board requested Mr. Gully to contact the County Commissioners Association of Ohio as well as other local governments for information on the cost and process of modifications and "overhauling" of their zoning codes.

Barry Sullivan, Zoning Supervisor, was present for the site plan review application of Joy Outdoor Education Center in Washington Township.

Mr. Sullivan presented the proposed plan to construct five cabins, a farm bathroom building, dining hall with restroom, adult cabin and fire pit, water garden pond and archery shelter.

There was discussion relative to any safety concerns from adjacent property owners due to the archery shelter.

Mr. Sullivan stated the proposed shelter is not close to any adjacent homes. He then stated his recommendation to approve the site plan review application subject to six conditions.

Upon further discussion, the Board resolved (Resolution #05-1209) to approve the site plan review application subject to six conditions.

Richard Renneker, Sanitary Engineer, was present for a work session and discussed the following matters:

Mark Hildebrandt, property owner in Hamilton Township, requested the Board to release his property for sanitary sewer service. The Board explained to Mr. Hildebrandt that his property was no longer in the sewer improvement area of the Warren County Sewer District. Upon discussion, Mr. Kilburn requested that a copy of this portion of the taped minutes be transmitted to the Regional Planning Commission. The Board then requested Mr. Renneker and Mr. Gully to send a letter to the RPC stating that sanitary sewers are not available to this property.

Mr. Renneker presented the preliminary plat of Kings Meadows in Deerfield Township. He stated that sewers are available as it is inside the sewer improvement area. The Board requested Mr. Renneker and Mr. Gully to send a letter to the RPC stating that sanitary sewers are available to this property.

The Board discussed the petition for water service at Shaker/Greentree Road. There was discussion relative to possible two property owners at the end of the line not wanting water. The Board requested Mr. Renneker to have Pat Nolan, Assistant Sanitary Engineer, contact the property owners and if they desire to be eliminated from the project, eliminate them to reduce the proposed assessment amount.

Upon motion the meeting was adjourned.
