PUBLIC HEARING

CONSIDER THE RE-EMPLOYMENT OF RICHARD RENNEKER, SANITARY ENGINEER UPON RETIREMENT

This Board met this 31st day of January 2006, for the public hearing to consider the reemployment of Richard Renneker, Sanitary Engineer, upon retirement.

Commissioner Kilburn gave the background information on the purpose of the public hearing and the laws that require the public hearing to be held.

Upon discussion, the Board resolved (Resolution #06-184) to continue the public hearing to February 7, 2006, at 10:30 a.m.

Richard Renneker, Sanitary Engineer, discussed the request of the Maineville Methodist Church to receive sanitary sewer service to their property in Hamilton Township that has been determined to be outside the sewer improvement area.

Upon discussion, the Board requested Mr. Renneker arrange for a representative from the church to be scheduled on the Commissioners' Agenda to discuss the request.

On motion, upon unanimous call of the roll, the Board entered into executive session at 11:11 a.m. to discuss personnel matters pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 11:48 a.m.

Robert Craig, Regional Planning Commission, was present along with Robert Ware, Richard Renneker, Bruce McGary, Jerry Spurling, Barry Sullivan, Mike Yetter and Dave McElroy, members of the Zoning Amendment Committee to present the proposed text amendment to the Warren County Rural Zoning Code relative to growth management.

Mr. Craig stated that in June of 2006, the Board has made a list of essential changes they desired to see in the Zoning Code and that these proposed amendments were the first step in meeting the request of the Board.

Bob Ware, Regional Planning Commission, reviewed the proposed changes with the Board.

Commissioners South stated her concern with the amendments as proposed and suggested the Zoning Amendment Committee revise the amendments in manner that would removed the sewered vs. unsewered language relative to density and further define the conservation/cluster development.

Commissioner Young stated his desire for the township trustees under the jurisdiction of County zoning to tell the Board the text amendments they desire to see in the Zoning Code.

On motion of Mrs. South, being seconded by Mr. Young, the Board requested Dave Gully, County Administrator, to draft a scope of services to be used in a request for qualifications for a consultant to complete an entire re-write of the Warren County Rural Zoning Code. They also requested Mr. Gully to work with the Prosecutor and staff along with the five townships under Warren County Zoning on draft amendments to the zoning code to remove the language of density being based on sewer vs. non-sewer property as well as amend the language on cluster developments. The Board requested the draft language to be completed and presented to the Board within the next thirty to sixty days.

Upon motion the meeting was adjourned.
