## DISCUSSIONS

Commissioner Kilburn was absent until 10:45 a.m. due to being in depositions relative to pending litigation.

Beth Callahan, Warren County Magazine, was present to discuss the magazine and explain why it was created.

Mrs. Callahan explained that Warren County is in the middle of both the Cincinnati and Dayton market and is therefore, left out most of the time. She stated that the Dayton Daily News is received by 9000 households and the Cincinnati Enquirer is received by 14,000 households, leaving numerous Warren County residents without any coverage. She then stated the magazine consists of 50% informational information and 50% advertising.

The Board discussed their desire to include informational articles relative to Warren County for the next six issues and utilize it as a way to reach the residents of Warren County.

On motion, the Board agreed to spend \$12,000 with Warren County Magazine to provide informational material in the next six issues relative to Warren County.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:45 a.m. to discuss personnel matters pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 11:08 a.m.

Sheriff Ariss was present along with various Sheriff's Office employees for a work session to discuss jail space.

Sheriff Ariss explained that there are a total of 213 beds within the jail. He then discussed the number of minimum, medium and maximum security beds and the policy that no violent criminal ever being turned away due to overcrowding. He explained that the average length of stay for an inmate is 18 days. He discussed the number of inmates that are being housed in the Miami County Jail and the need to make one trip per day to transport prisoners to and from Miami County.

Sheriff Ariss then presented the projection of inmate population for 2010 to be 476 beds needed.

Upon discussion, the Board stated their desire for the Sheriff to utilize a "big box store" for nonviolent offenders such of non-payment of child support and DUI offenders and consider rehabilitation of the "B" wing currently being utilized for storage prior to the Board considering expansion of the jail.

Upon motion the meeting was adjourned.
