There was discussion relative to medical needs being top priority as the Board desires for all children to receive medical care when needed.

Doris Bishop, Human Services Director, compared the difference between Warren County's PRC Plan and Butler County's PRC Plan.

Mr. Baily then requested the Board to amend their plan to not exclude locked out workers from the PRC Plan.

Upon discussion, the Board stated they would take the request under advisement.
