PUBLIC HEARING #1

ADOPTION OF THE 2006 RESIDENTIAL CODE OF OHIO

The first public hearing to consider the adoption of the 2006 Residential Code of Ohio was convened this 25th day of July 2006 in the Commissioners' Meeting Room.

Jerry Spurling, Chief Building Official, explained that the Board inadvertently adopted the 2004 Code rather than the 2006 Code. He then stated that the State of Ohio has determined they will not grandfather certification of inspectors who have not passed the testing. He then stated that the State of Ohio no longer requires the Board to hold public hearings relative to the adoption of new codes.

Upon further discussion, on motion, upon unanimous call of the roll, the public hearing was closed.
