On motion, upon unanimous call of the roll, executive session was entered into at 4:30 p.m. to discuss acquisition of property pursuant to Ohio Revised Code Section 121.22 (G)(2) and exited at 10:50 a.m.

Ryan Hunt, Morrow Police Department, was present along with John Heisler, Harveysburg Police Department, and representatives from the Warren County Telecommunications Department for a work session to discuss Mobile Data Computer (MDC) replacement.

Richard Elliott, Director of Telecommunications, presented four proposed options for the Board to consider relative to replacement of MDCs.

Upon consideration, the Board stated their desire to consider the proposals from Mr. Elliott and on motion, upon unanimous call of the roll, the Board approved the funding to replace two computers for the Morrow Police Department and two computers for the Harveysburg Police Department.

Kurt Weber, Chief Deputy County Engineer, was present to discuss the need to replace a bridge on Sharrod Road in Massie Township.

Mr. Weber stated that the bridge has been out for some time and they have not had the need to repair or replace it. He then stated that property that has previously been undeveloped is in process of being developed and they are obligated to provide access to the land.

Upon discussion, the Board requested Mr. Weber to search for cheaper alternatives than to spend that much money for a few property owners.
