PUBLIC HEARING

CONTINUATION OF THE PUBLIC HEARING TO CONSIDER AMENDMENTS TO THE WARREN COUNTY EROSION AND SEDIMENT CONTROL REGULATIONS

The public hearing to consider amendments to the Warren County Erosion and Sediment Control Regulations was reconvened this 14th day of November 2006, in the Commissioners' Meeting Room.

Dave McElroy, Soil and Water Conservation, reviewed the events of the previous hearings and stated the Committee has met to discuss grading of lots and has three options proposed:

- 1. As a condition of occupancy, finish grade is certified by a private engineer—estimated to cost builder between \$300-600
- 2. Soil and Water Conservation District hires two employees to confirm correct final grade prior to occupancy permit-estimated to cost builder \$150
- 3. Homebuilders' Association one year warranty calls for proper grading and drainage. They propose that the homeowner call them and they will take care of any problems—no cost to homeowner

Mr. McElroy stated that the Committee is making much progress and they plan to come to the Board with a recommendation in the very near future.

A representative from the Homebuilders' Association explained the one year warranty process and when questioned, stated there would be nothing they could do if the home was outside the one year or the builder was not a member of the HBA.

Neil Tunison, County Engineer, stated he would like to get the amendments to the Erosion and Sediment Control Regulations adopted as soon as possible and work on the grading amendment once a recommendation is reached by the Committee.

Commissioner Young stated the need to ensure that the proper grading and drainage is being completed and stated the need to work with the Homebuilders' Association to ensure a remedy is made.

There was discussion relative to the use of a temporary occupancy permit.

Bruce McGary, Chief Deputy Prosecutor, stated he would not recommend allowing temporary occupancy permits as there is no incentive to the builder to complete the improvements.

Mr. McElroy then read into the record additional minor modifications to the regulations.

There was discussion relative to the desire to see a final document prior to amendments being adopted.

Upon discussion, the Board resolved (Resolution #06-1939) to continue this public hearing to November 16, 2006, at 5:30 p.m.
