Neil Tunison, Warren County Engineer, will review bids for a recommendation at a later date.

Mike Yetter, Zoning Inspector, was present for the site plan review of Joy Outdoor Education Center in Washington Township.

Mr. Yetter reviewed the comments from all departments and agencies concerned and reviewed the proposed site plan review which includes the following improvements:

- A new four bedroom/2 bathroom staff house with a basement
- Replacement of an old housing structure with a new four bedroom/2 bathroom house
- A new River Village Shelter/bath house
- A new healthcare cottage
- Replacement of the bridge on Fordyce Road
- Replacement of the garage at a new location with additions

Mr. Yetter then stated the recommendation to approve the site plan review application.

Robert Miller, Camp Joy Facilities Director, stated the new houses are to replace the older staff housing which is in desperate need of repair.

Upon further discussion, the Board resolved (Resolution #07-40) to approve the site plan review application subject to one condition.

PUBLIC HEARING CONSIDER LODGING TAX PENALTY APPEAL OF QUALITY INN IN THE CITY OF FRANKLIN

The Board met this 9th day of January 2007 to consider the appeal of Quality Inn in the City of Franklin for the assessment of penalties relative to late filing of Lodging Tax.

Chris Watkins, Assistant Prosecutor, explained that Quality Inn owed August – October 2006 lodging tax. He stated they have paid the tax but was assessed a penalty for the late filing in the amount of \$826.68. He then stated that the penalty has been re-calculated and they only owe \$128.82.

Ajay Pandy, General Manager of Quality Inn, stated they do not have a problem paying the \$128.82 penalty and withdrew the appeal.

Kimm Coyner, Economic Development Director, was present along with representatives from Kinnett Consulting Group to present a summary of the Strategic Analysis for Warren County Economic Development within Warren County.
