DISCUSSIONS

On motion, upon unanimous call of the roll, the Board entered into executive session at 9:12 a.m. to discuss personnel matters pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 10:12 a.m.

Richard Renneker, Sanitary Engineer, was present along with Chris Brausch, Deputy Sanitary Engineer, and Dave Walling, Assistant Sanitary Engineer, and discussed the following matters:

- 1. EMH&T has advised of additional costs in the amount of \$47,500, more than double the original contract, which they claim have been completed without the knowledge or approval of Warren County.
- 2. Snook Road Sewer Connection—Three homes within the Snook Road Sewer Project were not able to connect to the sanitary sewer due to an error of Henderson & Bodwell. Mr. Renneker has established a way to connect the three homes to South Lebanon's Sanitary Sewer if they are in agreement. Mr. Renneker questioned if the Board would like him to discuss this matter with the Mayor of South Lebanon. The Board confirmed their desire to discuss the possibility with South Lebanon.
- 3. Expansion of the Lower Little Miami Wastewater Treatment Plant—Mr. Brausch informed the Board of the limited land remaining at the site in Deerfield Township after the completion of the expansion. He questioned the Board's desire to discuss the possibility of purchasing an easement, a portion of property or the entire parcel of an adjacent property owner. The Board stated their desire to do so.

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

The Board attended the Warren County Police Memorial ceremony in the parking lot of the Warren County Administration Building.
