Don Lynch, Salem Township property owner, was present to discuss zoning violations that have been filed against him by the Salem Township Zoning Inspector.

Mr. Lynch stated that his property is zoned business and that the township claims he is in violation of the zoning code due to a bus he has parked on the property. He then stated that the township trustees themselves have zoning violations on their personal real estate and that the Zoning Inspector has not issued violation against them.

He then stated there are residents within the township who have constructed buildings without a building permit and are therefore do not have tax assessments on their property as they should. He then stated that Mr. Dare has numerous vehicles parked at his business that do not have valid license which is the same violation that has been made against him and stated that the Salem Township Trustees are selectively prosecuting him and not other violators within the Township.

Bill Schreiner, Deputy Auditor, was present and stated that he would investigate the allegation of Mr. Lynch and if warranted, have the properties in question re-evaluated for real estate tax purposes.

Dave Gully, County Administrator, stated that Lois McKnight, Deerfield Township Zoning Inspector, has agreed to investigate the allegation of zoning violations on the properties that Mr. Lynch feels are in violation within Salem Township.

Mr. Lynch stated that he has requested additional time to complete the repairs on the bus that is in violation of the zoning code in order to sell it.

Bruce McGary, Chief Deputy Prosecutor and legal representative of the Salem Township Trustees, stated his dispute of 95% of Mr. Lynch's statement. He also stated that in 1983, Salem Township residents voted to handle their own zoning and hired a zoning inspector and therefore, this Board has no jurisdiction in the matter.

Richard Renneker, Sanitary Engineer, was present to discuss a request of a resident of Kirby Road that desires the Board to waive the non-participation fee for a 2<sup>nd</sup> house on their property.

Upon discussion, the Board stated they do not desire to approve the request.
