- 1. Judge Heath is considering taking over the Litter Collection Program.
- 2. There is a need to issue an RFQ/RFP for the relocation of the waterline to accommodate road improvements needed on SR 122 due to Middletown Hospital, coating/painting of an elevated storage tank, the removal of the Dixie Standpipe and the possible need for an equalization basin within Dale Acres in Hamilton Township. The Board stated their agreement to issue the RFQ/RFP.

3. Mr. Brausch presented a powerpoint presentation relative to an update of the on the Lower Little Miami Wastewater Treatment Plant Expansion Project. Michael Schepers, Warren County United Way, was present for the Kick-off of the 2007 Annual Food Drive. Upon discussion, the Board determined to provide \$40,000 to the Warren County United Way to be distributed to the eligible food pantries within Warren County in addition to the \$10,000 that this Board has already provided to the Franklin Community Services Food Pantry. Jake Jones, Building Services Director, was present for a work session to discuss pre-design cost estimates and various schemes relative to the renovation/expansion of the Common Pleas Court Building. On motion, upon unanimous call of the roll, the Board entered into executive session at 1:45 p.m. to discuss personnel matters pursuant to Ohio Revised Code Section 121,22 (G) (1) and exited at 1:50 p.m.
