On motion, upon unanimous call of the roll, the Board entered into executive session at 9:30 a.m. to discuss personnel matters pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 10:40 a.m.

## PUBLIC HEARING

## CONSIDER MODIFICATIONS TO THE RULES AND REGULATIONS OF THE WARREN COUNTY WATER AND SEWER DEPARTMENT RELATIVE TO AN INCREASE IN THE USER RATE AND TAP IN FEES

The Board met this 27<sup>th</sup> day of November 2007, in the Commissioners' Meeting Room to consider modifications to the Rules and Regulations of the Warren County Water and Sewer Department relative to an increase in the user rate and tap in fees.

Richard Renneker, Sanitary Engineer, stated that the proposed rate increase relative to water is 1% for the next three years. He then stated that the proposed sewer rate increase is 4% for the next two years and 3% the third year.

The Board quested if a 1% increase in the water rate is sufficient to cover future costs.

Patty Solinski, Business Manager within the Water and Sewer Department, stated that the proposed increases are what she has calculated will be necessary to cover operations and maintenance. She then stated that the sewer revenue for 2006 was \$6.649 million and the expenses were \$6.572 million. She stated the need to increase the rates is due to aging lines within the system as well as the increase in operation and maintenance due to the water treatment plant expansion and the sewer treatment plant proposed expansion.

The Board then reviewed the rate study survey presented by the Water and Sewer Department.

Mr. Renneker reviewed the proposed tap fee increases as follows:

Sewer	\$4000	\$4400	\$4800

Commissioner South stated that the Water and Sewer Department has presented realistic increases for the next three years.

Dan Hendricks, Cincinnati Home Builder's Association, stated that his organization has not had an opportunity to sit down with Mr. Renneker to review the proposal.

Upon discussion, the Board resolved (Resolution #07-1917) to continue the public hearing to December 18, 2007, at 12:00 p.m.

Richard Renneker, Sanitary Engineer, was present along with Chris Brausch, Deputy Sanitary Engineer, for the Board to interview the following engineering firms in order to select a firm for the Lebanon-Hamilton Deerfield Water Interconnection Project:

Jones Warner Consultants, Inc. CDS Associates, Inc. Henderson & Bodwell, LLP

Upon completion of the interview process and review of the selection ranking sheets by the Board, the Board resolved (Resolution #07-1922) to select Henderson and Bodwell, LLP as the

top ranked engineering firm and authorize the Water and Sewer Department to begin negotiations.
