Neil Tunison, County Engineer, Richard Renneker, Sanitary Engineer, Don Ashmore, Soil and Water Conservation, and Bruce McGary, Chief Deputy Prosecutor, were present to discuss the declaration of default of performance bonds for 21 Oaks Subdivision in Hamilton Township.

Mr. Tunison stated that Atlantic Homes, developer of 21 Oaks Subdivision, has declared bankruptcy and there are several defects within the subdivision that need corrected as well as final improvements which have never been completed.

Upon recommendation of Mr. McGary, the respective departments desire to declare the performance bonds in default in order to utilize the funds to correct problems and complete the subdivision as two of the lots have been sold and have private residences on them.

Upon discussion, the Board resolved (Resolution #08-593) to declare Atlantic Homes, Inc. to be in default in the performance and maintenance of all public improvements in the Twenty-One Oaks Subdivision located in Hamilton Township and apply performance and/or maintenance bonds to complete and/or maintain unapproved improvements and pursue deficiencies per the terms of all security agreements.
