### **PUBLIC HEARING**

#### CONTINUATION OF THE 2009 TAX BUDGET

The continuation of the public hearing to consider adoption of the 2009 County Tax Budget was reconvened this 15<sup>th</sup> day of July 2008, in the Commissioners' Meeting Room.

Tiffany Zindel, Office of Management and Budget Director, stated that we began 2008 with a \$62.8 million appropriation and with adjustments, are not at \$65.7 million. She then stated that the proposed tax budget has a final general fund budget of \$76,327,160.00.

Mrs. Zindel then presented the Board with two resolution to reduce the inside millage collected by both Warren County MR/DD and Warren County. She stated that the first resolution is a reduction of 2 mills being requested by MR/DD and the second is a reduction of .57 mills by this Board. She then stated that the net effect reduction will be 1.05 mills.

Commissioner Kilburn stated his concern relative to the expenditure by MR/DD for Miracle Field proposed at approximately \$400,000 and stated his desire to reduce the appropriation line item to not permit the expenditure. Mr. Kilburn then moved to adopt a resolution relative to same. The motion died for the lack of a second.

Upon further discussion, the Board resolved (Resolution #08-1021) to approve .57 mill reduction in the rate of Property Tax Entitlement within 10 mill limit, (Resolution #08-1022) to approve request for 2 mill reduction in the Levy collected for the Warren County Board of Mental Retardation and Developmental Disabilities and (Resolution #08-1023) to adopted the Warren County Tax Budget for Year 2009.

Mike Yetter, Zoning Inspector, was present for the site plan review application of Camp Kern in Turtlecreek Township.

Mr. Yetter explained the proposal of Camp Kern to construct 2 Sugar Wood Lodges, 6 Wilderness Cabins, 1 Wilderness Pavilion and 1 Recreational Hall. He then stated the comments from Officials and Department considered and stated he has received one call from a neighbor relative to a noise complaint. He then presented the Zoning staff recommendation to approve the site plan review application subject to five conditions.

Upon further discussion, the Board resolved (Resolution #08-1061) to approve the site plan review application subject to the following five conditions:

- 1. Structures to be ancillary to existing structure.
- 2. Driveways to be accessible for Fire and EMS vehicles to the satisfaction of the Turtlecreek Township Trustees.
- 3. Compliance with Section 3701-25-02 of the Ohio Administrative Code to include approval by the Warren County Combined Health District.
- 4. Compliance with parking and loading regulations (Chapter 20) and exterior lighting regulations (Section 27.05) of the Warren County Rural Zoning Code "A".
- 5. Building permit application to include site plan showing all driveways and walkways relative to accessibility of Fire and EMS.
