DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Richard Renneker, Sanitary Engineer, was present for a work session to discuss the following matters:

1. A policy relative to the acquisition of easements—Mr. Renneker presented a draft policy to the Board which includes a waiver of appraisals for easements under \$10,000 which has been approved by the Prosecutor's Office. Upon discussion, the Board resolved (Resolution #08-1093) to establish a policy for the waiving of property appraisals for the acquisition of Water and Sewer easements.

- 2. Utica Road/Old St. Rt. 122 Water Project—Mr. Renneker stated that the estimate for the assessment is approximately \$12,000 per benefited property. He then requested the Board to continue to the next step which would include the adoption of a resolution to approve tentative assessment. Mr. Kilburn stated he is not willing to authorize a \$12,000 assessment without 100% consent of all property owners.
- 3. Peter Carroll, Caesar Creek Lake Estates, has provided an amended petition, statement and waiver in order to increase the assessment relative to improvements within the subdivision. Upon discussion, the Board resolved (Resolution #08-1095 and 08-1096) to Amend Resolution 07-1603 and ratify and confirm modified tentative assessment, declare the necessity for the construction of the sanitary sewer improvements and determine to proceed with (in accordance with the Petition of Benefited Property Owner) the construction of sanitary sewer improvements in the Caesar Creek Estates Sewer Improvement Area, Warren County Sewer District and Levy Final Special Assessments for construction of improvements to the sewer system in the Caesar Creek Estates Sewer Improvement Area, Warren County Sewer District.
