On motion, upon unanimous call of the roll, the Board entered into executive session at 9:15 a.m. to discuss personnel matters relative to hiring personnel within the Sheriff's Office pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 10:21 a.m.

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Suzanne Mason, Solid Waste Management, was present to give an update on the Solid Waste Management District Activities for 2008.

Mrs. Mason presented the following information:

• Removed 35 tons of tires from the Engineer's Office

- Completed Annual District Report to the Ohio EPA
- Completed CSI's Grant: Recycling Toter Project
- Hosted Computer Recycling Day in Mason—collected 45 tons of computers
- Provided education in schools, fair, bank, etc.
- Work with Emergency Services after wind storm

The Board commended Mrs. Mason on the services being provided to the citizens of Warren County and requested that she continue doing an excellent job at an affordable cost to the district.

Mike Yetter, Zoning Department, was present for the site plan review application of Pennyroyal Baptist Church in Franklin Township.

Mr. Yetter stated that the church is proposing to construct at 50×100 foot accessory building for youth basketball and activities with no restroom facilities being proposed at this time. He then stated the comments from departments and officials concerned and stated the recommendation to approve the site plan review application subject to four conditions.

The Board discussed the proximity of the church and existing residential homes to the proposed building and upon discussion, the Board resolved (Resolution #08-1989) to approve the site plan review application subject to four conditions.

Upon motion the meeting was adjourned.
