SECTION 00040 - INVITATION TO BIDDERS

Separate sealed bids for the Bellbrook and Chenoweth Road Water Main Extension Project will be received by the Warren County Board of Commissioners at the Office of the Warren County Commissioners, 406 Justice Drive, Lebanon, Ohio 45036, until September 11, 2012 @ 9:05 a.m. and then at said time publicly opened and read aloud.

Bid documents and specifications may be obtained at the Warren County Water and Sewer Department, 406 Justice Drive, Lebanon, Ohio 45036, for a \$50.00 per set non-refundable fee. Questions regarding the technical specifications should be directed to Chris Brausch, Warren County Water and Sewer Department, (513) 695-1193.

The Project includes the construction of approximately 4,366 feet of 8-inch Class 52 ductile iron water main to provide water service to new customers in Wayne Township. The Engineer's opinion of probable construction cost is \$325,000.00.

A Bid guaranty, as required by Ohio Revised Code, Section 153.54, shall accompany each proposal submitted, as follows:

1. A Certified check, cashiers check, or letter of credit equal to ten (10) percent of the bid. A letter of credit may only be revocable by the Owner. Upon entering into a contract with the Owner, the contractor must file a performance bond for the amount of the contract, and the bid guaranty will then be returned to the successful and unsuccessful bidders upon contract execution.

OR

2. A form of bid guaranty bond (attached) for the full amount of the bid. Such bond is retained for the successful bidder, but returned to unsuccessful bidders after the contract is executed.

Attention of bidders is called to all of the requirements contained in the bid packet. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof. All bids shall be properly signed by an authorized representative of the bidder. All bids shall be sealed and plainly marked
