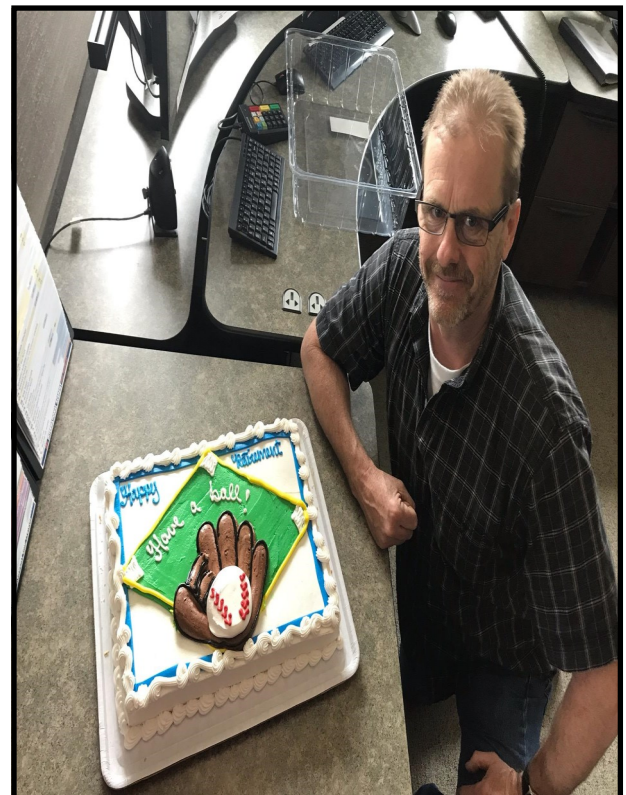

## Locates

Locates are placed on a record when an agency we dispatch for has located a wanted person, missing person or lost/stolen property that is entered into LEADS.

Once a Hit Confirmation **Request** has been sent, the department that holds the record will have 10 minutes to respond to an urgent request; which is the default or 1 hour (if selected). This agency then must send a Hit Confirmation **Response** (or equivalent) back to the department that is out with the record (person or property). Once the response has been received and the department advises the record is valid, regardless if they will make pick up or not, a locate will be placed on that record.

When placing a locate on a record, the recovering agency must advise on extradition. There are 3 options for extradition; 1) **Extradition**: used when the entering agency will pick up the subject (no local charges), 2) **Detention**: used when the recovering agency has local charges and will not meet to drop off the subject until they are finished with him/her, 3) **No Extradition**; used when the subject will not be extradited due to circumstances at the time , ie. jail full or cannot meet for pick up.

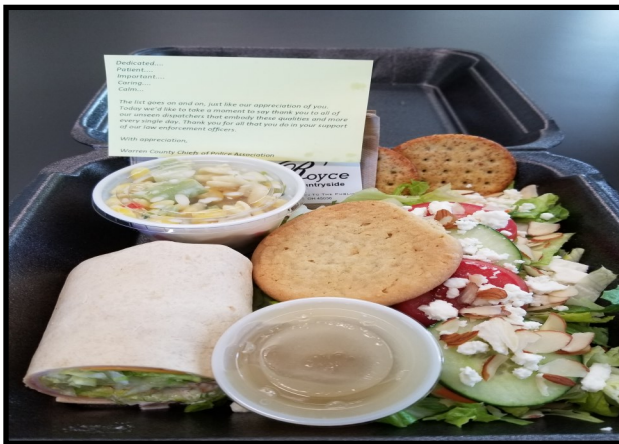
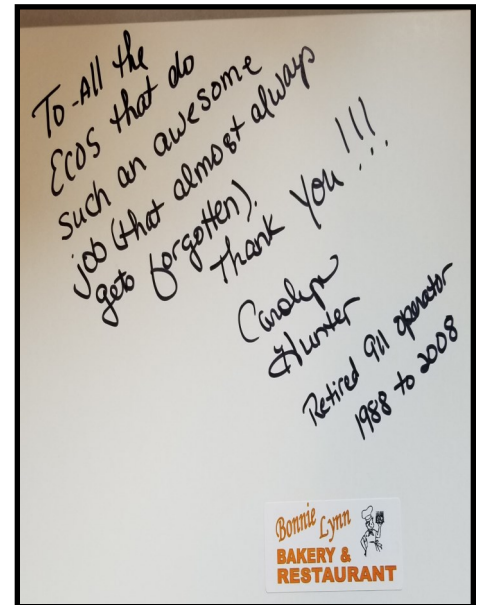
# Another Great National Telecommunicator's Week

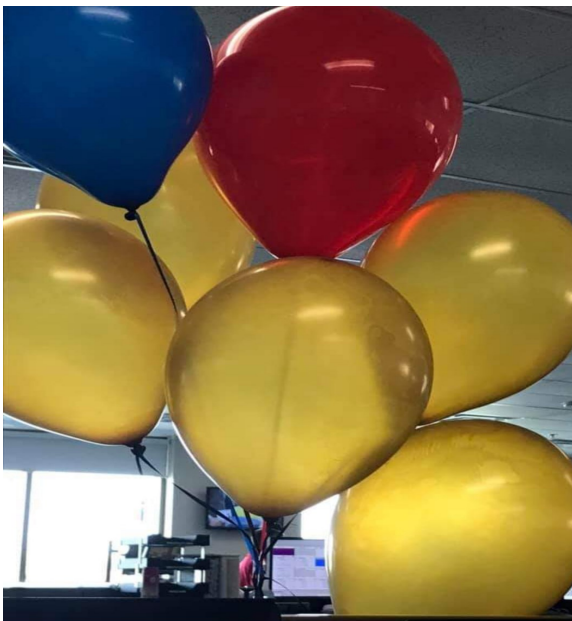

## Warren County Annual Police Memorial Service May 15, 2019

On Wednesday, May 15th, the Warren County Police Chiefs Association will honor our county's seven fallen officers at the annual Warren County Police Memorial Ceremony. Held in conjunction with National Police Week each May, the ceremony pays tribute to Officer George Basore (Franklin P.D), Sheriff W.E. Graham (Warren County Sheriff's Office), Deputy Homer Burlile (Warren County Sheriff's Office), Chief James Elder (Mason Police Department), Officer William Johnson (Springboro Police Department), Officer Jeffrey Phegley (Morrow Police Department), and Sergeant Brian Dulle (Warren County Sheriff's Office) who all gave their lives in service to their community. In addition to those who have fallen in the line of duty, a moment of silence will be dedicated to all Warren County Law Enforcement Officers who are no longer with us today.

The public is welcome to attend the ceremony that will be held directly outside the memorial near the Warren County Sheriff's Office, 822 Memorial Drive Lebanon, Ohio. Our featured speaker this year is Ohio's Attorney General David Yost. Those community members wishing to attend are asked to park at the Warren County Administration Building, 406 Justice Drive. Please make arrangements to arrive before the start of the ceremony at 11:00 a.m.

After completion of the ceremony, a procession will begin at the memorial and end at LIFEHOUSE Church, 2234 Utica Road, Lebanon, Ohio. Once the procession is complete, all surviving family members of fallen officers, elected officials, and all law enforcement officers are invited to remain at LIFEHOUSE Church to attend the FOP Memorial Luncheon provided by the Warren County Sheriff's Office and the Warren County Prosecutor's Office.
